Dear Catholic School Families:

May God's peace be with you. It is clear the situation regarding COVID-19 is constantly evolving. On Sunday, Governor Baker declared a three-week suspension of all public and private K-12 schools in the Commonwealth of Massachusetts. Last week, Catholic schools in the Diocese of Springfield enacted a plan for all Catholic schools to transition to remote learning through March 27, 2020. Because of Governor Baker's announcement, Catholic schools will remain closed for a minimum of three weeks, currently scheduled to reopen on April 7, 2020. The Catholic Schools Office will continue to monitor the State's response to this situation and recommend action based on any new information or mandates.

In preparation for what seemed to be inevitable with respect to school closures, all Diocesan Catholic schools began to transition to remote learning effective today, Monday, March 16, 2020. This will continue through April 6, 2020. As a result, your school leaders should have begun sending you updated information regarding your school's transition to remote instruction. The Catholic Schools Office is also currently developing additional directives, resources, and support for the Catholic schools to assure that students continue learning at home in the most reasonable and anxiety free manner. As a community of faith, please join us, starting tomorrow March 17, 2020 in praying a three-day Novena to St. Joseph for healing and a quick resolution to this unprecedented situation. The prayer finishes on St. Joseph's Feast Day, a day we fervently pray will mark the end of this pandemic.
